

Terms and Conditions

Agreement between user and Landskan, Inc. trading as "Landskan"

Our Licensing Models

Before you add a product into your shopping cart, you will have to decide which of the following licensing models to choose:

Single User License

This model allows for the use of the licensed material by one person.

Small Team License

This model allows for the use of the licensed material by up to 5 users within one company or other type of enterprise.

Team License

This model allows for the use of the licensed material by up to 10 users within one company or other type of enterprise.

Studio License

This model allows for the use of the licensed material by an unlimited number of users within the same company or enterprise at a single site (i.e. one building, campus or street address).

Installation/Storage

Licensed content may be stored on local hard disc as well as local network storage, considering it doesn't enable third parties outside of the licence agreement to access the data (as mentioned above). All licensed content may be used commercially (3d renderings, illustrations, real-time applications, image processing). No additional fees will be charged.

Intellectual Property

You acknowledge and agree that the statutory and other proprietary rights in respect of patents, designs, copyright, trademarks, processes, systems, drawings, data, specifications, documents, and other like rights relating to the Site or displayed or referred to on the Site are owned by Landskan or in some cases, third parties.

You must not reproduce, copy, transmit, adapt, publish or communicate or otherwise exercise the intellectual property rights in the whole or any part of the material contained on the Site except as provided for in these Terms or with the prior written consent of Landskan.

We do not grant you any licences, express or implied, to the intellectual property of Landskan or our licensors except as expressly authorised by these Terms.

Indemnification

You agree to indemnify, defend and hold harmless Landskan, its officers, directors, employees, agents and third parties, for any losses, costs, liabilities and expenses (including attorneys' fees on a solicitor and own client basis) relating to or arising out of your use of or inability to use the Site or services, any user postings made by you, your violation of any of these Terms or your violation of any rights of a third party, or your violation of any applicable laws, rules or regulations.
